

There are two parts to the catalogue:

- TCS/J/03 (pages 4-5) Records relating to the home that were created and used by Estates Department as part of its "Pink files" series.

#### A note on the name of The Children's Society:

The Children's Society has undergone a number of name changes during its lifetime. From its founding in 1881 until 1883, it was known as *The Church of England Central Home for Waifs and Strays*; from 1883 until 1893, it was known as *The Church of England Central Society for Providing Homes for Waifs and Strays*; and from 1893 until 1946, it was known as *The Church of England Incorporated Society for Providing Homes for Waifs and Strays*. Throughout this time, from 1881 until 1946, The Children's Society was commonly called *The Waifs and Strays Society*.

In 1946, it gained the name which is still its legal title, *The Church of England Children's Society*, even though it was renamed *The Children's Society* in 1982.

In order to avoid confusion in this catalogue when referring to The Children's Society and its previous incarnations, *The Children's Society* has been used for all records that date after 1946, and *The Society* has been used for all records that date before 1946.

#### Open records

#### **Closed records**

File of correspondence and documents relating to the purchase, running and sale of St Monica's Home for Diabetic Children, Kingsdown, Deal, Kent
1948-1972

Contains the following:

- Bundle of correspondence between The Children's Society, the home, new staff, and the British Diabetic Association, 1948-1971. Includes correspondence relating to: the appointment of chaplains, honorary treasurers and secretaries for the home, 1948-1970; a summer holiday camp for the children at the home, 1968-1969; and the closure of the home, 1971.
- Bundle of correspondence between The Children's Society, the home, diabetic charities, the Ministry of Education, the Lands Branch of the War Department, solicitors, surveyors and valuers, the vendors, and Corfield House Home, Rustington, Sussex. Includes correspondence relating to: the purchase of property, then known as 'The Sun Club', to be used as the home, by The Children's Society from the Anglo-American Relief Fund for London Children and Morthers Ltd, 1948-1949, with valuations of the property, 1948; compensation for temporary defence works beside the home under the Compensation (Defence) Act 1939, correspondence dated 1953; and the sale of the home from The Children's Society to RJ Hutchings, 1971-1972, with press cuttings regarding the sale, 1971-1972.
- Correspondence between The Children's Society, the home and Stanley Edgar Boatfield at Ashford, Kent, fruit grower, regarding the lease of a boathouse in Wellington Parade, Walmer, Kent, from Stanley Edgar Boatfield to The Children's Society, for the use of the home, at a rent of £13 per annum, 1953. Includes the rental agreement, 17 July 1953.
- Correspondence between The Children's Society and the home, regarding the visit of JE Diehl to the General Secretary of The Children's Society, 1970.
- Correspondence between The Children's Society and the wife of the treasurer of the home, regarding the treasurer's health, 1972.
- Copy petition forwarded to The Children's Society from the local district council, in which local residents of Kingsdown object to the sale of the home for it to be converted into a facility for young people with learning difficulties; petition made c1972, copy made c1972.
